HANS Device SFI 38.1 Recertifications

IMPORTANT, PLEASE READ THIS ENTIRE NOTICE ADDRESSING SFI RULE CHANGES REGARDING HEAD & NECK RESTRAINT RECERTIFICATIONS

Head and Neck Restraints must be recertified every 5 yrs. to receive a current SFI 38.1 conformance sticker.

Competitors racing with an SFI 38.1 Head & Neck Restraint device must have their device recertified every five years. For example, if your device was certified in January, 2018 or earlier, it will require recertification by February 1, 2023. Devices passing the inspection will receive a new SFI 38.1 conformance sticker marked with the inspection date that will remain valid for five years. Downing/Atlanta Inc. will certify a HANS device for a \$35 fee, plus return shipping. Expedited shipping is available.

***Most devices will require a new tether system, see Level 2 below. Please phone for payment**

ANCHOR AND TETHER OPTIONS

Standard Post Anchor and Tether System



Anchors mount on helmet.
Push and pull tether catch to release.

Quick Click Anchor and Tether System



Anchors mount on helmet.
Release by pull string.

SA and SAH HELMET ANCHORS

Anchors for SA and SAH Helmets Explained



SAH helmets have a threaded insert (nutwasher) bonded inside the helmet shell. Anchors for these helmets screw directly into this insert and are sold without nutwashers.



Anchors for SA helmets include two nutwashers.



Anchors for SAH helmets do not include nutwashers.
